All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being **on the Southeastern side of Avon Drive near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 126 as shown on a plat of Avon Park, prepared by C. C. Jones & Associates, dated November, 1956, and recorded in the R. M. C. Office for Greenville County, South Carolina in Plat Book KK at page 71 and having according to said plat the following metes and bounds:**
