"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the Southwestern corner of Ravensworth Road and Brook Glenn Gardens, being shown as Lot 23 on a plat of Brook Glenn Gardens, mecorded in Plat Book JJJ at page 85, and being more fully described as follows:
