"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township and being known and designated as lot No 4 on plat of property of Judson Mill in Subdivision known as Edgement and shown on plat thereof recorded in the RMC Office for Greenville County in Plat Book D, at page 35. Said lot being located on Piedmont Avenue and fronts thereon 60 feet and has a depth of 150 feet. This property is shown on the County Block Book at 115-1-11 and being a portion of the property conveyed to C.P. Dill by J.T.
