NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all Improvements, thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs. Township, near the southern limits of the Town of Green, on the south side of Spring Street, and designated as Lot 76 and the eastern half of Lot 77 on a plat of the subdivision of the N. E. Gannon land, made by H. S. Brockman, Surveyor, January 16, 1924, and described as follows:

BEGINNING at an iron pin on the south side of Spring Street, joint corner of Lots 75 and 76 on said plat, and runs thence as the dividing line between said lots, S. 13 E. 167.7 feet to a pin on the Smith land; thence S. 77 W. 75 feet to a stake on the Smith line; thence N. 13 W. 168.5 feet to a pin on Spring Street, which point is the middle of the front line of Lot 77; thence N. 76-45 E. 75 feet to the beginning corner. Bounded north by Spring Street; east by Lot 75; south by the Smith land, and west by the western half of Lot 77.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
