BEGINNING at an iron pin at the northwestern intersection of Lake Drive with Hunts Bridge Road, and running thence with Hunts Bridge Road, N. 13-56 W. 100 feet; thence S. 88-34 W. 492.5 feet; thence S. 29-15 W. 85.5 feet to an iron pin on the north side of Lake Drive; thence with Lake Drive the following courses and distances, to wit: S. 43-46 E. 68.3 feet; S. 67-36 E. 64 feet; N. 88-34 E. 320.1 feet; N. 78-04 E. 59 feet; N. 67-31 E. 116 feet to the point of beginning, and being the same property conveyed to J.
