EMMERSON D. STURGILL and BARBARA E. STURGILL of
Greenville County, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto

securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of Greenville,
State of South Carolina:

ALL that piece, parcel or lot of land, together with buildings and im-
provements, lying on the Eastern side of Old White Horse Road in
Greenville County, South Carolina, being shown as Lot No. 4 on a Plat
entitled "Re-Subdivision for Central Realty Corp.", made by Pickell &
Pickell, Engineers, dated July 25, 1946, and recorded in the RMC Office
for Greenville County, S. C., in Plat Book B, page 82, reference to
which is hereby craved for the metes and bounds thereof.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belong-
ing or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be
had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter
attached to or used in connection with the real estate herein described.
