or at such other place as the holder of the note may designate in writing, in monthly installments of  
Eighty-seven and 08/100 - - - - - Dollars (\$ 87.08 ),  
commencing on the first day of January , 19 67, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of December , 1991

Now, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville , State of South Carolina:

All that lot of land in the city of Greenville, county of Greenville, state of South Carolina, being a portion of Lots Nos. 1 and 2, and all of lot No. 2A as shown on plat of property of C. A. Talley and O. M. Howard recorded in the RMC Office for Greenville County in Plat Book G at page 162, and having according to said plat and a recent survey made by H. C. Clarkson, Jr., R.L.S. Oct. 1966, the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin on the north side of Otis Street, which pin is 117 feet southwest from the northeast corner of the intersection of Elm and Otis Streets; thence with a new line through the rear of lots Nos. 1 & 2, N. 18-0 W. 126 feet to an iron pin; thence N. 72-0 E. 53 feet to an iron pin; thence S. 18-0 E. 126 feet to an iron pin on the north side of Otis Street; thence with the north side of said street S. 72-0 W. 53 feet to the beginning corner.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises are free and clear of all liens and encumbrances whatsoever. The Mortgagor further covenants to warrant and forever defend all and singular the premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
