TO ALL WHOM THESE PRESENTS MAY CONCERN: **M. G. PROFFITT, INC.**

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of -----  
**Twenty-two Thousand Six Hundred and no/100-----** DOLLARS

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, **on the eastern side of Aldridge Drive in the City of Greenville, being shown as Lot 56 on plat of Section F of Gower Estates recorded in the RMC Office for Greenville County in Plat Book JJJ at page 99, and more fully described as follows:**

**Beginning at an iron pin on the eastern side of Aldridge Drive at corner of Lot 55; thence with the eastern side of said Drive, N. 19-54 W. 115 feet to an iron pin at corner of Lot 57; thence with line of said lot, N. 70-06 E. 180 feet to an iron pin in line of Lot 31; thence with lines of Lots 31 and 32, S. 19-54 E. 115 feet to an iron pin at corner of Lot 55; thence with line of said lot, S. 70-06 W. 180 feet to the beginning corner.**
