ALL that piece, parcel or lot of land situate, lying and being on the western side of Bedford Lane near the City of Greenville, in the County of Greenville, State of South Carolina and known and designated as Lot No. 64 of a subdivision known as Avon Park, plat of which is recorded in the R.M.C. Office for Greenville County in Plat Book KK at Pages 70 and 71; said lot having such metes and bounds as shown thereon.
