Ware ----- (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto ANDERSON SAVINGS AND LOAN ASSOCIATION, Inc., Anderson, S. C. (hereinafter referred to as Mortgagee), a South Carolina Corporation, as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Ninety-eight hundred Fifty-five & No/100 DOLLARS (\$ 9855.00**), with interest thereon from date at the rate of **Seven (7%)** per centum per annum, said principal and interest to be repaid in monthly installments of **Seventy-six and 41/100** ---- Dollars (\$ **76.41**) each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest, computed and paid monthly in advance, and then to payment of principal, and

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of ~~Anderson~~ Greenville, **Gantt Township, being more particularly shown as Lot No. 133 on a plat made by Piedmont Engineers and Architects dated September 28, 1964 and revised January 28, 1966, of record in the Office of the Register of Mesne Conveyance for Greenville County in Plat Book 3-J, at page 179. Said lot lies on the southern side of Blossom Drive and fronts thereon for 75 feet, extends back on its eastern and western boundaries for a distance of 133 feet and is 75 feet in width along the rear lot line.**
