TO ALL WHOM THESE PRESENTS MAY CONCERN: we, Jacob R. Pruitt and Rosemary C. Pruitt

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto WOODRUFF FEDERAL SAVINGS AND LOAN ASSOCIATION, (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of NINETEEN THOUSAND and no/100--- DOLLARS (\$19,000.00), with interest thereon from date at the rate as specified in said note, said principal and interest to be repaid as therein stated, and

All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greer, being known and designated as Lot No. Nine (9) on plat of Pleasant View Acres prepared by H. S. Brockman, Surveyor, dated March 22, 1954 and recorded in the R. M. C. Office for said County in Plat Book FF, page 365, said lot being described as follows: Beginning at an iron pin on the southern side of Gravely Road, joint corner of Lots Nos. 9 and 10, and running thence with said road S.58-33 W.160.2 feet to an iron pin at the joint front corner with Lot No. 8; thence with the line of Lot No. 8, S.13-07 E.249.3 feet to an iron pin on the line of Lot No. 6; thence N.80-45 E.70 feet to an iron pin; thence N.2 E.315.4 feet to the beginning corner.
