WHEREAS, We, Jimmy R. Sims, J. R. Sims and Virginia P. Sims

(hereinafter referred to as Mortgagor) is well and truly indebted unto **Southern Bank and Trust Company**

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Five Thousand** - - - - - Dollars (\$ **5,000.00**) due and payable

One Year after date

with interest thereon from date at the rate of **6 1/2** per centum per annum, to be paid: **annually**

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Dunklin Township on the North side of the Dunklin Bridge Road, containing 2 acres, more or less, being all the remainder and balance of a 3.15 acres, more or less, tract of land which was conveyed to J. R. Sims by deed of R. L. Sims on the 20th day of February 1951, of record in the R. M. C. Office for Greenville County, S. C., in Deed Book 429, Page 358, reference also being made to a plat of the same made by T. J. Leslie, Surveyor, February 2, 1951; reference also being made to a deed from J. R. Sims to J. Carl Storay & Helen S. Storay, April 1, 1954, of record in said R. M. C. Office in Deed Book 497, Page 243; also to a deed this day made to Frank J. Sims and Lois C. Sims by the said J. R. Sims to be recorded and also to a deed made this day to the said Jimmy R. Sims by the said J. R. Sims to be recorded herewith. On the two (2) acres, more or less, being covered by this mortgage, the remainder of the 3.15 acres, more or less, tract is situated the brick-veneer residence occupied by the said J. R. Sims and family for a number of years and other out buildings.

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
