SEND GREETING:

WHEREAS, I the said Mae Charles Hill

in and by my certain promissory note in writing of even date with these Presents, am well and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of **Seven thousand and no/100 - - - - - (\$ 7,000.00 )** Dollars, with interest from the date hereof at the rate of **seven** per cent ( **7 %**) per annum, unpaid interest to bear interest at the same rate, to be repaid in installments of

BEGINNING on an iron pin on the West side of Spring Street and running thence N. 80-05 W. 141.4 feet to an iron pin; thence S. 8-27 W. 69.4 feet; thence S. 86-27 E. 140.3 feet to an iron pin on the West side of Spring Street; thence therewith, N. 10-08 E. 54 feet to the point of beginning.
