"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Charlbury Street, in the City of Greenville, being shown as Lot 22 on plat of Section F of Gower Estates, recorded in Plat Book JJJ at Page 99, and described as follows:

"BEGINNING at an iron pin on the eastern side of Charlbury Street, at corner of Lot 23, and running thence with the eastern side of said Street, S. 19-56 E. 110 feet to iron pin, corner of Lot 21; thence with line of said lot N. 70-04 E. 179.5 feet to iron pin; thence N. 19-50 W. 110 feet to iron pin at corner of Lot 23; thence with line of said lot S. 70-04 W. 179.7 feet to the beginning corner."
