Fourteen (14), Fifteen (15) and Sixteen (16) of the P. O. Copeland Estate as shown on plat no. 3 prepared by H. S. Brockman, Reg. Surveyor, dated August 6, 1958 and which plat has been recorded in the R. M. C. Office for said County in Plat Book KK, page 135.
