to an iron pin on the northwest side of said Road S. 32-44 W. 125 feet to a point; thence continuing S. 23-19 W. 87.7 feet to a point; thence with the curve of said road as it intersects with Pine Knoll Drive, the chord of which is S. 87-33 W. 17.3 feet to a point on the northeast side of Pine Knoll Drive; thence with the northeast side of said Drive N. 27-40 W. 134.9 feet to the beginning corner.

TOGETHER with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining. TO HAVE AND TO HOLD all and singular the said premises unto the said The Citizens and Southern National Bank, its successors and assigns forever. And we do hereby bind ourselves, ourheirs, executors, administrators, successors and assigns to warrant and forever defend all and singular the said premises unto the said The Citizens and Southern National Bank its and assigns, from and against us, our heirs, executors, administrators, successors and assigns, and all other persons whomsoever lawfully claiming or to claim the same or any part thereof.
