\$97.80 per month for 8 consecutive months beginning March 10, 1967

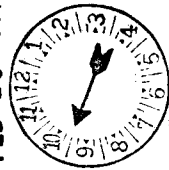
with interest thereon from date at the rate of 6 per centum per annum, to be paid: in advance
