Hudson, recorded in Plat Book "A" at page 163, as an unnumbered lot, lying between lots 9 and 10, as shown on said plat, and being more particularly described as follows:

BEGINNING at an iron pin on the Southern side of Dunbar Street, opposite the intersection of Memminger and Dunbar Streets, and running thence with said Dunbar Street, S. 76 E. 80 feet to an iron pin in line of Lot No. 10; thence with line of said lot, S. 18 W. 215 feet to an iron pin; thence N. 76 W. 80 feet to an iron pin in line of Lot 9; thence with line of said lot, N. 18 E. 215 feet to the point of beginning.
