WHEREAS, We, M. P. Watson and Mary Watson

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Oaklawn Township, and being a part of the W. Arthur Campbell home place lying and being situated on the Southside of the new State Highway No. 418 containing 8.93 one hundredths acres, more or less according to survey and plat made by C. O. Riddle, Surveyor, dated April 21, 1965, which shows the following courses and distances to wit:

BEGINNING at Iron Pin on the Southside of South Carolina Highway 418 and the Northeastern corner of this lot and running thence S. 19-06 E. 350.2 feet to Iron Pin, thence along Wade Chandler line S. 50-20 W. 826.1 feet to Iron Pin, thence N. 19-23 W. 653.6 feet to point on the Southside of said highway, thence along Southside of Highway N. 71-50 E. 777.3 feet to beginning corner. Bounded on the North by said Highway, on the East by R. A. Coker, on the South by Wade Chandler and on the West by E. P. Watson.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
