WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

(6-3/4%) per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, lying on Woodleigh Drive, being shown and designated as Lot No. 116 in Section 3, on a plat of subdivision known as COLONIAL HILLS, which plat is on record in the R.M.C. Office for Greenville County in Plat Book BBB, page 91, and having the following courses and distances:

BEGINNING at an iron pin on the northern side of Woodleigh Drive, joint front corner of Lots Nos. 22 and 116, and running thence with the joint line of Lots Nos. 22, 23 and 116, N. 4-27 E. 224.6 feet to an iron pin, joint rear corner of Lots Nos. 23 and 116; thence along the rear line of Lots Nos. 25 and 116, S. 80-15 E. 70 feet to an iron pin, joint rear corner of Lots Nos. 115 and 116; thence with the joint line of said lots, S. 11-01 E. 188.8 feet to an iron pin on the northern side of Woodleigh Drive, joint front corner of said lots; thence with said Drive, S. 77-41 W. 125 feet to an iron pin, the point of beginning.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
