ALL that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Town of Simpsonville, and shown as the Western-most lot of a Plat of property of J. R. Richardson, Sr., by C. O. Riddle, dated August 28, 1964, and recorded in the R.M.C. Office for Greenville County in Plat Book III, at page 57 and having, according to said Plat, the following metes and bounds:

BEGINNING at an iron pin on the Northern side of an unnamed gravel road on the Line of the D. B. Goldsmith Estate, and running thence N. 17-56 W. 281 feet to an iron pin; thence N. 85-00 E. 61.4 feet to an iron pin on the line of other property of J. R. Richardson, as shown on said plat, and running thence with said Lot, S. 17-04 E. 278.9 feet to an iron pin on the Northern side of a gravel road, property of L. R.
