TO ALL WHOM THESE PRESENTS MAY CONCERN:

Mary B. Abrams, (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Seven Thousand Six Hundred and 00/100 -----

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the County of Greenville, State of South Carolina, being known and designated as Lot No. 202, Subdivision of Mills Mill, and having, according to a plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book GG, Pages 60 and 61, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Hill Street at the joint front corner of Lots Nos. 201 and 202, and running thence with the joint line of said lots, S 84-53 W 103.4 feet to an iron pin; thence N 21-20 W 78.3 feet to an iron pin; thence with the joint line of Lots Nos. 202 and 203, N 82-50 E 128.7 feet to an iron pin on the western side of Hill Street; thence with the western side of Hill Street, S 2-45 E 80 feet to the point of beginning.
