BEGINNING at an iron pin on the South side of Highlawn Ave. joint corner of Lot # 8 & 9 which point is 143.6 ft. East of the southeast corner of the intersection of Highlawn Ave. with Worth St., thence along the south side of Highlawn Ave. S. 79-10 E. 71.3 ft. thence S. 10-50 E. 137.38 ft to beginning corner. This being the same property conveyed to me by FW Miller dated May 22, 1943 recorded in Vol. 253, page 392.

To have and to hold, with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging, unto said Mortgagee, provided always, and this instrument is made, executed, sealed and delivered upon the express condition that if the said Mortgagors shall pay in full to the said Mortgagee the above-described Note according to the terms thereof, then this Mortgage shall cease, determine and be void, otherwise it shall remain in full force and virtue.
