C. and being designated as Lot No. 38 of a subdivision known as Stratford Forest and having according to a plat of said subdivision prepared by Piedmont Engineering Service, dated February 25, 1957, and recorded in the RMC Office for Greenville County, S. C. in Plat Book KK, page 89, the following metes and bounds, to wit:

BEGINNING at an iron pin on the southerly side of South Warwick Road, joint corner of Lots 37 and 38 and running thence with the line of Lot No. 37 S 13-20 W 225 feet to an iron pin in the line of Lot No. 36 thence along Lot No. 36 and with the subdivision property line N 74-07 W 193.7 feet to an iron pin; thence continuing with said subdivision property line N 11-55 E 232.6 feet to an iron pin on the southerly side of South Warwick Road; thence along the southerly side of South Warwick Road S 72-05 E 200 feet to the point of beginning.
