- 4. If the integers falls to make any payments provided for in this section or any other payments for taxes, assessments, or the like, the light gages may pay the same, and all saids so paid shall bear interest at the rate set forth in the note secured hereby from the date of such advance and shall be secured by this mortgage.
- 5. That he will keep the premises in as good order and condition as they are now and will not commit or pairmit any waste thereof, reasonable wear and tear encepted.
- 6. That he will keep the improvements now existing or hereafter erected on the mortgaged proitigs and c may be required from time to time by the Mortgagee against loss by fire and other hazards, co gencies in such amounts and for such periods as may be required by the Mortgages and will pay romptly, when due, any premiums on such insurance provision for payment of which has not been made lessely All maur since shall be carried in companies approved by the Mortgagee and the policies and renewels there bhall be held by the Mortgagee and have attached thereto loss payable clauses in favor of and in form accepta gazee. The Mortgagor covenants and agrees that so long as this mortgage and the said note secured hereby are insured under the provisions of the National Housing Act, he will not execute or file for record any instrument which imposes a restriction upon the sale or occupancy of the mortgaged property on the basis of ace, color, or creed. Upon any violation of this undertaking, the Mortgagee may, at its option, declare the unpaid salance of the debt secured hereby immediately due and payable.

It is agreed that the Mortgagor shall hold and enjoy the premises above conveyed until there is a default under this mortgage or in the note secured hereby. The Mortgagor waives the benefit of any appraisement laws of the State of South Carolina. Should any legal proceedings be instituted for the foreclosure of this mortgage, or should the Mortgagee become a party to any suit involving this mortgage or the title to the premises described herein, or should the debt secured hereby or any part thereof be placed in the hands of an attorney at law for collection by suit or otherwise, all costs and expenses (including continuation of abstract) incurred by the Mortgagee, and a reasonable attorney's fee, shall thereupon become due and payable immediately or on demand, at the option of the Mortgagee, as a part of the debt secured hereby, and may be recovered and collected hereunder.
