All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of **Greenville**, on the **North side of Milford Drive, near Milford Baptist Church, Oneal Township**, and being known and designated as lots Nos. Four (4), Five (5), Six (6), Seven (7), Eight (8) and Nine (9) of the W. Dennis Smith property as shown on plat prepared for mortgagor herein by H. S. Brockman and John A.
