All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Northeastern side of Latham Drive near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 38 as shown on a plat of Farmington Acres, Section 2, prepared by Carolina Engineering & Surveying Co., dated July 21, 1965, recorded in the R.M.C.
