

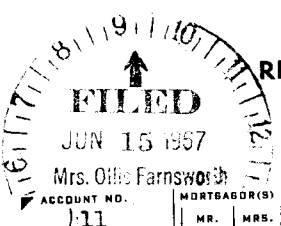

NOW KNOW ALL MEN, that in consideration of said loan and to further secure the payment of said Note and also in consideration of three dollars (\$3) to the Mortgagors in hand well and truly paid by Mortgagee at and before the sealing and delivery of these presents, receipt whereof is hereby acknowledged, the Mortgagors hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate, situated in the County of Greenville, State of South Carolina, to-wit: lying on both sides of Mt. Grove School road and bounded by lands of Lee O'Neal, Tom Bowers, Bryson Williams, Boyce Bramlett and other land of Grantor and containing Sixteen and 7/10 acres, more or less, and having the following meter and bounds:

BEGINNING at an iron pin on the north side of McCauley Creek and running thence with O'Neal land line S. 12-45 W. 1577 feet to a stone and iron pin (Benson Land Corner); thence S. 87-00 E. 73.2 feet stone; thence N. 74-45 E. 1090 feet to an iron pin; N 58-45 W. 285 feet to Stone (N.M.); thence N. 27-45 W. 900 feet to iron post; thence N. 2-30 E. 298.6 feet to stake; thence N. 85-00

To have and to hold with and unto the Mortgagee, its successors and assigns, the rights, members, hereditaments and appurtenances to the said premises belonging, unto said Mortgagee, provided always, and this instrument is made, executed, sealed and delivered upon the express condition that if the said Mortgagors shall pay in full to the said Mortgagee the above-described Note according to the terms thereof, then this Mortgage shall cease, determine and be void, otherwise it shall remain in full force and virtue. Upon default in making any payment of said Note when the payment becomes due, then the entire sum remaining unpaid on said Note shall be due and payable by the exercise of the option of acceleration above described, and this Mortgage may be foreclosed as provided by law for the purpose of satisfying and paying the entire indebtedness secured hereby.

The Mortgagors covenant that they exclusively possess and own said property free and clear of all encumbrances, except as otherwise noted, and will warrant and defend the same against all persons except the Mortgagee. Any failure of the Mortgagee to enforce any of its rights or remedies hereunder shall not be a waiver of its rights to do so thereafter. Whenever the context so requires, plural words shall be construed in the singular.
