TO ALL WHOM THESE PRESENTS MAY CONCERN: I, W. Dennis Smith

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in O'Neal Township, on East side of Memorial Drive Extension, about three miles Northwest of the Town of Greer, and being known and designated as lot No. Fifteen (15) of the W. Dennis Smith property as shown on plat prepared by John A. Simmons, Registered Surveyor, dated April 30, 1960 and which plat has been recorded in the R. M. C. Office for said County in Plat Book 00, page 491. This being the same property which was conveyed to Gary J. Davis by W. Dennis Smith by deed which has been recorded in the said office in Deed Book 673, page 398. And being a part of the property which was devised to Ruth W. Davis by her late husband, Gary J. Davis by Will filed in Apt. no. 957, File no. 18 in the Probate Judge's office for said County. This being the same property which was conveyed to mortgagor herein by Ruth W.
