"All ~~that~~ ^{those} certain pieces, parcels or lots of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northerly side of S. C. Highway No. 253, being shown and designated as Lot No. 3 and the adjoining 34 feet of Lot No. 2, as shown on plat of Fontana Forest, recorded in the RMC Office for Greenville County, S. C., in Plat Book "YY", at Page 171, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the northerly side of S. C. Highway No. 253 at the joint front corner of Lots Nos. 3 and 4, and running thence N. 16-58 W. 161.9 feet to an iron pin; running thence N. 70-37 E. 100 feet to an iron pin at the joint rear corner of Lots Nos. 2 and 3; running thence N. 70-37 E. 34 feet to a point in the rear line of Lot No. 2; thence on a new line through Lot No. 2 S. 16-55 E. 159 feet to the northerly side of S. C. Highway No. 253; running thence with said Highway S. 67-10 W. 34 feet to the joint front corner of Lots Nos. 2 and 3; thence continuing with said Highway S. 69-10 W. 100 feet to the point of BEGINNING.
