(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

Six Thousand - - - - -  
DOLLARS (\$ 6,000.00 ), with interest thereon from date at the rate of Six & one-half (6½%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, situated on the corner of Bessie Avenue and the J. Waymon Smith Road near Pleasant Grove Baptist Church, about one mile southward from the City of Greer, and being Lot No. 50 of WOODLAND HEIGHTS, property of I.M. Wood Estate according to survey and plat by H. S. Brockman, Registered Surveyor, dated October 28, 1955, recorded in Plat Book GG, page 151, R.M.C. Office for Greenville County, and having the following courses and distances, to-wit:

BEGINNING at an iron pin at the northwest corner of Bessie Avenue and the J. Waymond Smith Road, and running thence along the western boundary of said road, N. 39-55 W. 85 feet to an iron pin at the corner of Lot No. 51; thence along the southern boundary of this lot, S. 45-18 W. 246.5 feet to an iron pin in line of Lot No. 53; thence along the eastern line of this lot, S. 39-15 E. 85 feet to an iron pin in the northern boundary of Bessie Avenue; thence along the northern boundary of said Avenue, N. 45-18 E. 247.5 feet to the beginning point.

This is the same property conveyed to the mortgagor herein by deed from Boyd E. Odom dated February 7, 1966 recorded in R.M.C. Office for Greenville County. See also deed recorded in R.M.C. Office for Greenville County in Deed Book 647, page 204.
