To All Whom These Presents May Concern: Wooten Corporation of Wilmington

(herein called mortgagor) SENDS GREETING:

a corporation chartered under the laws of the State of South Carolina, is well and truly indebted

All that certain piece, parcel or lot of land, together with improvements thereon, situate, lying and being at the southeastern corner of the intersection of Mapleton Drive and Dalegrove Drive in the County of Greenville, State of South Carolina, being shown and designated as Lot 121 on plat of Pine Forest recorded in the Greenville County R. M. C. Office in Plat Book QQ, pages 106-107, and having, according to said plat, the following metes and bounds, to-wit:
