All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of **Greenville**, containing **25 acres, more or less, on the branch waters of Enoree River, situate in Bates Township and having the following metes and bounds, to-wit:**
