All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, lying on the western side of Theodore Circle, shown as lot 16 on a plat of Carolina Heights, Section 2, which plat is recorded in the R.M.C. Office for Greenville County in plat book "BBB", Page 161, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Theodore Circle, at the joint front corner of lots 16 and 15, and running thence with the joint line of said lots, S. 87-12 W., 183.2 ft. to an iron pin; thence S. 48-52 E., 210 ft. to an iron pin at the joint rear corner of lots 16 and 17; thence with the joint line of said lots, N. 41-08 E., 120.1 ft. to an iron pin on the western side of Theodore Circle; thence with the curve of said Circle, the cords of which are N. 68-33 W., 45 ft. to an iron pin and N. 17-04 W., 42 ft. to an iron pin at the point of beginning.
