"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, **City of Greer, Chick Springs Township, located on North Main Street, and being more fully described as follows:**

Beginning at an iron pin on Miss Sallie Wilson corner, and running thence S. 82-20 E. 200 feet to an iron pin; thence N. 8-45 W. 80 feet to an iron pin; thence N. 82-20 W. 200 feet to an iron pin on East bank of North Main Street; thence S. 8-45 E. 80 feet to the beginning corner.

ALSO: A strip of land adjoining the above property, more fully described as follows:
