(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of -----

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, **on the northern side of Berea Drive in Paris Mountain Township, having according to plat of the Property of Mae Davis Hill, recorded in Plat Book MMM at page 5, the following metes and bounds:**

Beginning at an iron pin on the northern side of Berea Drive at corner of property heretofore conveyed to Harriet Hunt; thence with line of Hunt property, N. 41-50 W. 408 feet to an iron pin; thence S. 88-11 W. 31 feet to an iron pin on Singleton Circle; thence with the southern side of Singleton Circle, as follows: S. 10-57 W. 75 feet; thence S. 26-52 W. 75 feet; S. 51-22 W. 153 feet to an iron pin at rear of Lot 8; thence with the rear line of Lots 8 and 9, S. 30-45 E. 180 feet to an iron pin; thence with line of Lots 10 and 12, S. 38-30 E. 208.1 feet to an iron pin on Berea Drive; thence with the northeastern side of Berea Drive, 425 feet to the beginning.
