"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs

Township, located about one-half mile southwest of the corporate limits of the City of Greer, being shown as Lots Nos. 29,30,31,32,33 and 34 on a plat of property made for the Sam H. James Estate by H. L. Dunahoo, Surveyor, recorded in the R.M.C. Office for Greenville County, and being the identical property conveyed to us, the mortgagors, by deed of Mrs. Bessie Taylor Mallard, recorded in Deed Book 620 Page 417, R.M.C. Office, for and having the following courses and distances:
