ALL that certain piece, parcel or lot of land situate, lying and being in Paris Mountain Township, Greenville County, State of South Carolina, on the Southern side of Sharon Drive, near the City of Greenville, being shown as Lot No. 9 on plat of Sharon Park recorded in Plat Book EE, at page 175,R.M.C. Office for Greenville County and described as follows:
