NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of

All that piece, parcel or lot of land situate, lying and being in the City and County of Greenville, State of South Carolina, on the northern side of Fernwood Lane and being known and designated as Lot No. 55 on plat of Cleveland Forest recorded in the R. M. C. Office for Greenville County in Plat Book "K", at Page 46, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Fernwood Lane at the joint front corner of Lots Nos. 54 and 55 and running thence along the joint line of said lots N. 13-23 W. 156.3 feet to an iron pin; thence S. 87-16 W. 120 feet to an iron pin on the eastern side of an alleyway; thence along the eastern side of said alley S. 32-34 E. 155 feet; thence with the curve of the intersection of said alley and Fernwood Lane, the chord of which is S. 59-30 E. 26.8 feet to an iron pin; thence along the northern side of Fernwood Lane S. 86-24 E. 50 feet to the point of beginning.
