TO ALL WHOM THESE PRESENTS MAY CONCERN: Alvin J. Hill and Eunice M. Hill

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto **The Peoples National Bank,  
Greenville, S.C.**

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of - - - - -

**THIRTY TWO HUNDRED AND NO/100THS- - - - - DOLLARS (\$ 3200.00 )**,  
with interest thereon from date at the rate of **6-1/2%** per centum per annum, said principal and interest to be repaid: **\$188.00 on January 17, 1968, and a like sum of \$188.00 quarterly thereafter, said payments to be first applied to interest and balance to principal until paid in full**

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, **situate at the northwestern corner of the intersection of Second Street and Orders Street (formerly Second Avenue), being shown as Lot 11, Block 7, Page 151 of the County Block Book, and also shown as part of Lot 1, Block K on plat of Park Place recorded in Plat Book A at page 119. Said lot fronts 45 feet on the western side of Orders Street and extends back along Second Street 55 feet.**

This being the same property conveyed to the Mortgagors herein by deed of Josie Nadine Robertson Cole (formerly Josie Nadine Robertson) to be recorded herewith.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
