"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, on the northwestern side of Anderson Road and being known and designated as Lot No. 16 on plat of property of Mollie Fortner, et al recorded in the R. M. C. Office for Greenville County in Plat Book "F", at Page 73, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Anderson Road at the joint front corner of Lots Nos. 15 and 16 and running thence along said Road N. 44-26 E. 50 feet to an iron pin; thence along the joint line of Lots Nos. 16 and 17 N. 50-34 W. 188.7 feet to an iron pin; thence S. 34-34 W. 50 feet to an iron pin; thence along the joint line of Lots Nos. 15 and 16 S. 50-34 E. 180.3 feet to the point of beginning.
