NOW, KNOW ALL MEN, That I, the said Donald E. Baltz

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said W. W. Wilkins,

All that piece, parcel or lot of land situate, lying and bein on the eastern side of the Laurens Road (U.S. Highway #276) in the town of Mauldin, state and county afore-said, containing 3 1/10 acres, and having according to a survey made by J. A. Pickens dated May 19, 1951 the following metes and bounds, to-wit:

Beginning at an iron pin on the easterly side of Laurens Road (U. S. Highway 276) which iron pin is a joint corner with property of Coke Alexander, and is also located 2/10 of a mile more or less in a northerly direction from the intersection of Laurens Road (U.S. Highway #276) with County road at which intersection the U. S.
