(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **---Fifteen Thousand Two Hundred and No/100-----** DOLLARS (\$ 15,200.00 .), with interest thereon from date at the rate of **--Six and three-fourths** per centum per annum, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being **on Longmeadow Road in the County of Greenville, State of South Carolina, being known and designated as Lot No. 2, Block A, of Brook Glenn Gardens, Section No. 2, as shown on plat thereof recorded in the RMC Office for Greenville County in Plat Book "WWW", page 5, and having according to said plat the following metes and bounds, to-wit:**
