N. Blair Bridle and Ether Lea Bridle ----- of  
Greenville, South Carolina -----, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto Collateral Investment Company -----

-----, a corporation organized and existing under the laws of Alabama -----, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Ten Thousand Five Hundred and No/100 ----- Dollars (\$ 10,500.00 -----), with interest from date at the rate of Six ----- per centum (----- 6 %) per annum until paid, said principal and interest being payable at the office of Collateral Investment Company ----- in Birmingham, Alabama -----

All that piece, parcel or lot of land situate, lying and being at the northeastern corner of the intersection of Donnan Road and Dove Lane near the City of Greenville, in the County of Greenville, State of South Carolina and known and designated as Lot No. 160 of a subdivision known as Super Highway Home Sites; plat of which is recorded in the R.
