JIMMY A. COOKE AND SHIRLEY B. COOKE

...(hereinafter referred to as Mortgagor) SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of Lighteen.

Thousand One Hundred and No/100-----
Ollars, as evidenced by Mortgagor's promissory note of even date herewith, said note to be repaid with interest at the rate

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for such proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagoe to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northerly side of Tamarack Trail, being shown and designated as Lot No. 18, and a portion of Lot No. 17, on plat of Fontana Forest, recorded in the RMC Office for Greenville County, S. C., in Plat Book "YY", at Page 171, and having, according to a more recent plat of Property of Jimmie A. and Shirley B. Cooke, prepared by C. O. Riddle, RLS, July 31, 1967, the following metes and bounds, to wit:

BEGINNING at an iron pin on the northerly side of Tamarack Trail at the joint front corner of Lots Nos. 18 and 19, and running thence with the joint line of said lots N. 17-37 W. 175 feet to an iron pin; running thence S. 72-23 W. 100 feet to an iron pin at the joint rear corner of Lots Nos. 17 and 18; thence continuing S. 72-23 W. 60 feet to a new iron pin in the rear line of Lot No. 17; thence on a new line through Lot No. 17 S. 22-38 E. 175.8 feet to a new iron pin in the front line of Lot No. 17 on the northerly side of Tamarack Trail; running thence with the northerly side of Tamarack Trail N. 72-23 E. 145 feet to the point of BEGINNING.
