corner of said lot; thence N. 45-55 E. 356 feet to an iron pin at the rear corner  
of Tract No. 10; thence along the line of that lot, S. 45-15 E. 454 feet to the

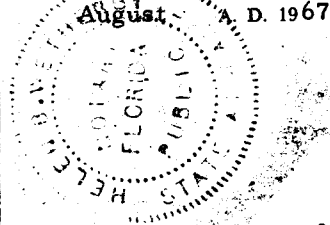
