WHEREAS, the Mortgagor is well and truly indebted unto TRAVELERS REST FEDERAL SAVINGS AND LOAN ASSOCIATION OF Travelers Rest, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Twelve Thousand Nine Hundred Fifty and No/100ths--**

DOLLARS (\$ 12,950.00), with interest thereon from date at the rate of **6 3/4%** per centum per annum, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, known as Lot Nos. 74 and 75 as shown on Plat of Coleman Heights recorded in Plat Book RR at page 115 and having the following metes and bounds to-wit:

BEGINNING at an iron pin on the southern side of Tugaloo Road (Highway S-131) at the corner of Lot No. 76; thence N 74-53 W 143.8 feet to an iron pin; thence along the curve of the intersection of Tugaloo Road and Mill Creek Road on a 25 degree radius to a point on the western side of Mill Creek Road; thence S 20-35 W 180.5 feet to the corner of Lot No. 73; thence S 75-04 W 159.4 feet to an iron pin at the corner of Lot No. 76; thence N 15-05 W 184.9 feet to the point of beginning and being same property conveyed to me by deed of Stanley I.
