and by these presents do grant, bargain, sell and release unto the said Margaret P. Smith the  
following described property.

Being the full contents of Lots Nos. two (2) and three (3), Block B, as shown on plat  
of Pinehurst, recorded in R. M. C. Office for Greenville County, South Carolina in  
Plat Book "S" at Page 77 and being the identical property conveyed to Kenneth W.  
Hill by Leslie and Shaw, Inc. by deed dated January 28, 1959 and recorded in  
Book 615 at Page 527 in the R. M. C. Office for Greenville County, South Carolina,  
located in Chick Springs Township, described as follows:
