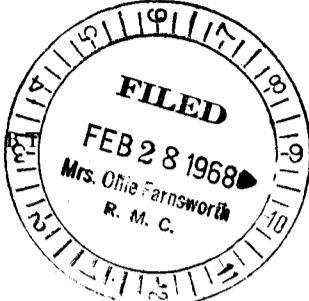

DEED TO SECURE DE

(\$1,716.00) DOLLARS, in hand paid by the party of the second part, at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and conveyed and by these presents does grant, bargain, sell and convey to the party of the second part, the following described real estate, to-wit:

ALL that piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being in Greenville County, South Carolina, being known and designated as Lot No. 4 of Paris Piney Park, plat of which is recorded in the RMC Office for Greenville County, S. C. in Plat Book "H" at pages 19 and 20, and according to said plat, having the following metes and bounds, to-wit:

BEGINNING at the Southwesterly intersection of Paris Mountain Road with Orlando Avenue and running thence with Paris Mountain Road S. 65-40 W., 50 feet to joint front corner of Lots 3 and 4; thence with the line of said lots S. 24-20 E., 150 feet; thence N. 65-40 E., 50 feet to a point on the westerly side of Orlando Avenue; thence with Orlando Avenue N. 24-20 W., 150 feet to the point of beginning.
