BEGINNING at an iron pin on the western side of Canterbury Road, joint front corner of Lots 32 and 33 and running thence N. 72-30 W. 250 feet to an iron pin on the rear line of Lot 39; thence along the rear line of that lot and continuing along the rear line of Lot 38, N. 15-28 E. 225.1 feet to an iron pin; thence S. 72-30 E. 258 feet to an iron pin on the western side of Canterbury Road; thence along the western side of Canterbury Road, S. 17-30 W. 225 feet to the beginning corner.
